**REPORTS** 

SHERIFF - The Trustees reviewed the Sheriff Report for January 2016.

ZONING – Mr. Gottschalk reported that he spoke to Mrs. Jarchow of 2315 Recker Road and discussed two items. She asked why not enforcing zoning at the old Linke farm at 1422 Fremont Pike. She also discussed the commercial trucks at Truman Road and Pemberville Road.

Mr. Gottschalk present the 2015 zoning report for the Trustees to review.
