REPORTS

ZONING – Mr. Gottschalk reported that the Zoning Board of Appeals tabled the meeting concerning the Haas zoning variance.

Mr. Gottschalk discussed two properties that need to be mowed. Mr. Gottschalk will give Mrs. Biniker the names and addresses and letters will be prepared for the next meeting.

EMS – Mr. Richardson reported the Emergency Management Agency received 5 portable light towers from a grant from Homeland Security. EMA gave one to Troy Township Fire Department. The Trustees signed the document from EMA. The portable light has to be added to our insurance. Mr. Richardson reported the value at \$2,000.00.

Mr. Richardson reported that the training for the EMS Charts was good. The software will be updated. Mr. Richardson reported that he had to take a laptop to follow along with the training.

The information will be sent to Paul Dobson, Prosecuting Attorney to review the contact. The contact at the Attorney General's Office stated that the Wood County Clerk of Courts uses their services.
