RESOLUTION 8-2023

Resolution to Revise Cemetery Rules, Regulations and Restrictions  
Troy Township Cemeteries, Luckey, Ohio 43443

The Board of Trustees of Troy Township, in Wood County, Ohio met in regular session on the 28th day of June 2023, at the 237 Krotzer Avenue, Luckey, Ohio 43443 with the following Trustees present: Richard P. Greulich, Jr., Kenneth J. Recker and Matthew L. Brinker.

Mr. Recker moved the adoption of the following Resolution:

WHEREAS, The Trustees of Troy Township, Pursuant to Ohio Revised Code Section 517 operates Troy Township Cemetery located at 518 Krotzer Avenue, Luckey, Ohio 43443 and Salem Grace United ELCA, Inc. located at 20144 Bradner Road, Pemberville, Ohio 43450; and

WHEREAS, According to Ohio Revised Code 517.11 provides that "The Board of Township Trustees shall provide for the protection and preservation of cemeteries under its jurisdiction. In addition, Ohio Revised Code 517.06 specifically provides that: The Board shall make and enforce all needful rules and regulations for the division of the cemetery into lots, for the allotment of lots to families or individual, and for the care, supervision, and improvements of the lots. Additionally, Ohio Revised Code 517.12 authorizes "rules specifying the times when cemeteries shall be closed to the public."

WHEREAS, The Trustees of Troy Township, have revised the Rules, Regulations and Restrictions;

WHEREAS, The Trustees of Troy Township will have the following signs at the cemeteries:

- 1) All pets must be on a lease
- 2) Cemetery will be closed sunset to sunrise
- 3) Water not for human consumption
- 4) No permanent fixture shall be placed on the grave
- 5) All winter wreaths, blankets, plants, flowers, decorations, shepherd hooks, etc. must be removed by March 15<sup>th</sup>
- 6) No new decorations until April 1<sup>st</sup>
- 7) Decorations remaining after March 15<sup>th</sup> will be removed by cemetery personnel

WHEREAS, the Trustees of Troy Township will publish this Resolution 8-2023 on the Troy Township internet web site ([www.troytownship.org](http://www.troytownship.org)) along with the Revised Cemetery Rules, Regulations and Restrictions;

WHEREAS, the Trustees of Troy Township will publish this Resolution 8-2023 in the Public Notices of the Sentinel Tribune;

NOW, THEREFORE, be it Resolved that effective September 1, 2023 the updated Rules, Regulations and Restrictions will become effective.
