RESOLUTION 4-2022

Resolution for Trustees to Reentry Cemetery Lots

The Board of Trustees of Troy Township, in Wood County, Ohio met in regular session on the 13th day of July 2022, at the 237 Krotzer Avenue, Luckey, Ohio 43443 with the following Trustees present: Richard P. Greulich, Jr. and Kenneth J. Recker (Matthew L. Brinker was absent).

Mr. Recker moved the adoption of the following Resolution:

WHEREAS, The Trustees of Troy Township, Pursuant to Ohio Revised Code Section 517 operates Troy Township Cemetery located at 518 Krotzer Avenue, Luckey, Ohio 43443 and Salem Grace United ELCA, Inc. located at 20144 Bradner Road, Pemberville, Ohio 43450; and

WHEREAS, it is necessary to provide for efficient management and use of space in these cemeteries; and

WHEREAS, Ohio Revised Code Section 517.073 outlines the authority for reentry for unused lots or rights; and

WHEREAS, Ohio Revised Code Section 517.073(A) the Board of Trustees may reenter a lot for which the terms of sale or deed was executed before July 24, 1986 or before September 29, 2015.; and

WHEREAS, Darius Carpenter purchased Lot 238, Graves 1 -9 in Section B in Troy Township Cemetery located at 518 Krotzer Avenue, Luckey, Ohio 43443 approximately in 1904. The last place of residence is Risingsun, Ohio; and

WHEREAS, the Trustees of Troy Township will publish this Resolution 4-2022 on the Troy Township internet web site (www.troytownship.org);

WHEREAS, since the owner or owner's heirs address is unknown and cannot be obtained reasonably, the Trustees of Troy Township will publish this Resolution 4-2022 in the Sentinel Tribune, Wood County, Ohio in the Public Notice Section; and


WHEREAS, the owner or his heir's have 180 days from date of publication in the Sentinel Tribune to contact Sexton, Todd Gottschalk at the Troy Township Cemetery at 419-494-6811;

NOW, THEREFORE, be it Resolved that after 180 days the interest in Graves 9 of Lot 238 in Section B will cease unless the owner or his heirs respond.


Mr. Greulich seconded the Resolution and the roll being called upon the vote resulted as follows:
